The **Sugar House Merchants Association** presents the sixth annual **Sugar House Arts Festival** on Monday, July 4<sup>th</sup> 2005. Boasting Salt Lake City's premier artists and craftsmen, festival-goers will enjoy perusing booths to live music and delicious food. Located in the heart of Sugar House, the festival is designed to enhance 4<sup>th</sup> of July activities traditionally held at Sugar House Park, where 100,000 visitor were in attendance last year.

Applications are due by May 1<sup>st</sup> 2005. Slides or photos for adjuring are to be submitted with application. Artists who wish their slides or photos to be returned must include a self addressed stamped envelope with adequate postage. SMA is not responsible for lost or damaged slides. A detailed description of vendor booths and products must be included with application.

There are a limited number of booths available, spaces are 12' x 12'. The fees are as follows:

\* A \$25.00 non-refundable adjuring fee is included in the booth fee.

5. Exhibitors will be responsible for thoroughly removing all trash (macro and micro) from their booth space to appropriate area (Failure to comply will result in forfeiture of deposit).
6. All sales will be made directly through the exhibiting artists.
7. Exhibitors will be responsible for collection (and remittance) of 6.6% sales tax. Instructions for collection procedures will be handed out the day of the Festival, Compliments of the Utah State Tax Commission.
8. Submission of this signed application is considered a commitment to exhibit at the Sugar House Arts Festival. No refunds, if application is accepted.
9. The Sugar House Merchants Association reserves the right to refuse any application.
10. All artists and vendors must remain inside of the space allotted to them.
11. The Sugar House Arts Festival reserves the right to remove any exhibitor for violation of any regulations.
